### **Supplier Upload Format**

System Requires: **Pipe symbol delimited text file OR Excel Spreadsheet. System currently supports only pipe symbol delimited text file for FTP drop off.** All 32 items of a record should be in this order, separated by pipe symbol "|"

- 1. Each record must be separated by the carriage return
- 2. Fields in red are always required; those in blue are required only when the country is USA (or US or code =1)
- 3. The remaining fields are optional. If you have no data for these non-required fields, the pipe symbols" |" must still be included, even though the field space will be blank.
- 4. United States Country Code is USA or US or "1" or United States of America
- 5. For each of the demographic fields you would use Yes or Y or 1 to indicate "yes" or No or N or "0" or a null field to indicate "no". In some cases abbreviated values are acceptable for these fields. Refer to the table below for a complete list of acceptable values for each of these fields. The fields this refers to are: Small Business, Minority Owned, Woman Owned, Hubzone, Small Disadvantage, Veteran Owned, Service Disabled Veteran Owned, Historically Black College & University, and Large Business.
- 6. Small vs. Large: A business cannot be "yes" for both small and large. Your choices are
  - a. "1" or Yes for small and "0" or No for large; or
  - b. "0" or No for small and "1" or Yes for large; or,
  - c. Blank (Null field) for Both if you don't know the business size
- 7. Ethnicity Options are:
  - 1 = White (not Hispanic) 6 = Subcontinent Asian American
  - 2 = African American 8 = Asian Pacific American
  - 3 = Hispanic American 10 = Canadian Aboriginal
  - 4 = Native American

#### The following Instruction Applies to companies using the Tier-X system to conduct a 2nd Tier Program ONLY.

If you require a vendor to report 2nd tier to you, then the "Required to Report" field for the record should be "1" or "Yes". If you do not require the vendor to report 2nd tier to you, then the "Required to Report" should be "0" or "No" or null field.
